PERSONAL DATA COLLECTION

Types of Personal Data We Collect About You

"Personal Data" refers to data that identifies or can be used to identify, contact, or locate a person or device associated with that data. Personal Data includes, but is not limited to, name, address, date of birth, phone number, email address, gender, identification (including passport or national identity documents) or other government-issued identifiers, photo, citizenship, phone numbers of Users and non-Users in your mobile contact list, and other data classified as Personal Data according to applicable regulations. To avoid doubt, applicable regulations refer to all applicable laws, budgets, legislations, regulations, policy regulations, ordinances, protocols, industry codes, traffic codes, regulatory permits or requirements from any court, tribunal, or government authority, as well as endorsements, regulations, administrative or judicial authorities or oversight bodies, applicable from time to time during the term of this Privacy Notice ("Applicable Regulations").

Additionally, other data, including personal profiles and/or unique identifiers, linked or combined with Personal Data, also constitute Personal Data.

The types of Personal Data we collect depend on the circumstances of collection and the nature of the requested services or transactions conducted.

To the extent permitted by Applicable Regulations, we may process, collect, use, store, and transfer various types of Personal Data, which we categorize as follows:

- 1. **Personal Information** including name, username, password, identification card, tax identification number, user identity or other identifiers, title, date of birth, gender, place of birth, occupation, nationality, photo, and/or biometric data.

Disclosure of Your Personal Data
